Purpose - The MTAOSA Orff--Schulwerk Certification Scholarship provides financial aid to a person who is interested in attending a certification course in the Orff-Schulwerk method.

- The funds must be used for training at an AOSA approved certification program or extension course.
- The applicant must show personal financial need.
- The applicant must be a current member of MTAOSA and must have been an MTAOSA member in good standing for one year prior to the application.
- Preference will be given to those who are applying for Level I.
- Scholarship amount is **\$400**

Application Process

The application must be completed and returned by **May1st**. The application should be mailed to the committee person at the address listed above.

2 copies of the application need to be submitted – one fully completed and one with ALL identifying personal information (name, address, name of workplace, etc.) removed for use by the committee members for unbiased judgment.

Responsibility of the Recipient

1. The recipient will attend and successfully complete an Orff-Schulwerk certification course. The recipient will provide a copy of their certificate of completion to MTAOSA.
2. The recipient will present at the MTAOSA Chapter Share workshop in the fall after taking the course.
3. The recipient will write a brief article after course completion about their experience in the Orff-Schulwerk Levels. This article will be used in future promotion related to this scholarship by this chapter.
4. This scholarship must be repaid if any of the following circumstances should occur:
 - The course chosen is cancelled.
 - The recipient fails to complete the course.

I have read the above information regarding the MTAOSA Orff-Schulwerk Certification Scholarship. I understand that if I were unable to complete the course due to any of the above circumstances the moneys would be returned to the MTAOSA chapter.
